

# Southwold Primary School – Nursery Funding and Charges

This information should assist you in understanding how the nursery operates and how your child's place is funded or paid for. When you request a place we ask you to complete a nursery admission form and a **Parent Authorisation Form (PAF)** for early education funding for 3 to 4-year-olds and eligible 2 year-olds. The PAF must be completed for all applications for free childcare and must be checked and re-submitted every term.

## Who pays for your child's nursery place

### WHAT'S FREE (FUNDED BY THE GOVERNMENT)?

All 3 to 4-year-olds in England can get free early education or childcare. This is a statutory entitlement which starts the term **after** the child's 3<sup>rd</sup> birthday and **parents/carers can request up to 15 hours per week during the academic year** (the normal school year).

Some 2-year-olds are also eligible for 15 hours free early education or childcare, for example if the parent or carer receives certain benefits, or works a minimum of 16 hours per week. If eligible, funding starts the term **after** the child's 2<sup>nd</sup> birthday: these are sometimes called "**Golden Ticket**" places.

The free early education and childcare must be with an approved childcare provider – **Southwold Primary School Nursery is an approved childcare provider** for children aged 2-to-4-years.

The free early education and childcare stops when your child starts in a school reception class (or reaches compulsory school age, if later).

If you are entitled an 11-digit code is generated, and you need to let us know the code so that we can use it to guarantee your child's nursery place and funding. Please note that once a code has been confirmed the **funding begins at the start of the following term**.

## WHAT HOURS AND SESSIONS DO WE OFFER?

Our opening times are: 08:30am to 15:15pm, Monday to Friday throughout the school year (38 weeks).

Morning session is 08:30-11:30am.

Lunchtime is 11:30-12:15pm

Afternoon session is 12:15-15:15pm.

Whole day (2 sessions plus lunch) is 08:30-15:15pm.

Nursery sessions consist of three-hour blocks. There are 10 blocks across the week.

We offer a maximum of 30 hours per child, per week.

Funded hours are provided on a weekly basis, any missed sessions are not carried forward to subsequent weeks but we may have flexibility within the nursery week if you need to change your child's attendance in exceptional circumstances.

## WHAT DO YOU TO PAY FOR?

You would pay for any nursery sessions the child attends **before** they are eligible for free childcare. This is because basic free (funded) childcare always starts **the term after the child's 3<sup>rd</sup> birthday** (or 2<sup>nd</sup> birthday if you are eligible for the 2-year old funding or "Golden Ticket" funding).

You would pay for additional sessions taken over and above the 15 hours early education funding for 3 to 4-year-olds, and eligible 2-year-olds. **An additional nursery session costs £15 for up to 3 hours.** We offer a maximum of 30 hours per child, per week, term-time only.

If your child attends in the mornings and you would like them to stay for lunch, you pay for their care and supervision over the lunch break. This is charged at £3.00 and children can bring a packed lunch, or the charge is £5.80 if you would like them to have a school meal.

There is no discount for siblings. Each child's funding and any additional chargeable sessions is unique to that child.

**Note: Lunchtimes usually fall outside the funded hours and there is a flat rate charge of £3.00 for care and supervision over the lunch break. However, for any child not using their statutory entitlement (for those with a 15 or 30 hour funded place), their "spare" hours can be used to cover their lunch times. You would provide a packed lunch or pay the standard £2.80 meal charge.**

**Snacks and Milk:** We offer a variety of snacks in small, manageable portions and charge £10 per child each term. Milk is provided free.

## SCENARIOS

A child attends 5 mornings (15 hours funded) and is collected at 11:30am. There is nothing else to pay.

A child attends 5 mornings (15 hours funded) and stays until 12:15pm once a week with a packed lunch. You would pay £3.00 for the lunchtime care on the day they stay during the lunch break. If they had a school lunch, you would pay £3.0 for the lunchtime care and £2.80 for the meal.

A child attends 5 mornings and 5 afternoons and is eligible for 30 hours funding, they have a school lunch every day so the cost would be £3.00 each day for the lunchtime care and £2.80 each day for the meal - £15.00 plus £14.00 = £29.00 to pay each week.

A child attends 3 whole days, so 6 sessions and 3 lunchtimes. You would use the 15 hours funding for 3 mornings and 2 afternoons: you would pay £15 for the 6<sup>th</sup> session, then £3.00 each day for the lunchtime care and £2.80 for a cooked lunch if they do not have a packed lunch.

## HOW AND WHEN DO YOU PAY?

Fees are payable in advance each half-term, so up to six times a year. The amount to pay is determined by the planned sessions your child will attend for the coming half-term.

Please be aware that some missed sessions are chargeable depending on the reason for absence.

You will receive an invoice near the beginning of each half term. Additionally, we keep a record of every child's attendance and we use this to work out any additional charges, including lunchtime care (where applicable) and any extra nursery sessions over your statutory entitlement. These would be added to the invoice for the following half-term, or in a separate invoice if your child leaves the nursery.

You are required to pay these invoices when requested and within two weeks of the invoice date.

All payments are made online via the Arbor Parent Portal and specific instructions are given on the invoices.
